

LETTER TO OUR SUPPORTERS

Dear Friends and Supporters,

On March 17, 2020, in response to the statewide COVID-19 shutdown, we closed our offices, gathered files and laptops, and sent our staff home to work at their kitchen tables, in their bedrooms, and if they were lucky - spare offices. It felt ominous, but I assumed it would be short-lived.

I was wrong

In short order, we found ourselves forced to adapt to this new reality and figure out on the fly how to best serve our many clients and those newly unemployed and in need of legal help. Attorneys became frontline workers, attending courts where they might be unable to social distance and were often the only one masked. We set up zoom hearing rooms, so our clients who lacked internet or camera could attend court in our offices. For seniors wanting to execute advance directives, we instituted a drive-thru model, setting up tents in parking lots where notaries and staff alike assisted. Our outreach went virtual - Facebook Live "Know Your Rights" events with community partners, informational cartoon videos on our YouTube channel, and Expungement Summits conducted on a variety of virtual platforms.

The silver lining of the COVID-19 pandemic is that it spurred innovation and ingenuity in our response at Land of Lincoln. But the economic and social toll of this pandemic, not to mention the human suffering and devastating loss of lives, have had a striking impact on our staff and our clients. I felt a lump welling in my throat a few days ago as I reviewed cases staff have designated "COVID-related: "a grandmother seeking custody of her grandkids after her daughter died of COVID; another client who got COVID, was hospitalized, took three months to partially recover and was in danger of getting evicted because he couldn't work. While Land of Lincoln is uniquely situated to help them resolve these legal problems and provide some peace of mind, we know it will take years for our community members to heal.



A FRESH START

A Land of Lincoln attorney assisted Tony, a veteran who made a good living as a truck driver after completing his military service and returning to civilian life. Tony had gone through a period in which he struggled with drug addiction that resulted in the loss of good paying jobs. He also received several felony convictions.

After his last arrest over 10 years ago, Tony successfully completed rehab and has been drug-free ever since.

Since becoming sober, Tony was able to get a job as a truck driver and has worked his way up the ranks. He applied for a promotion to a supervisory position, but was turned down due to his convictions.

Our attorney filed a petition to seal and expunge Tony's records. After the state's attorney objected, the attorney presented Tony at a hearing. Tony testified at the hearing about how he had changed and the impact his criminal record had on his life and his employment prospects. The court granted expungement of two records and sealing of three. Tony's employer has been supportive of his efforts to expunge and seal his records, and notified him that he is likely to receive the promotion.





JUSTICE FOR TENANTS

In August 2020, Madison County was continuing to hold eviction hearings, but entering judgments with dates after the Governor's eviction moratorium order was set to expire. The Governor's moratorium orders had been entered every 30 days, so some of the eviction judgments had dates on them that were in violation of the current moratorium order (e.g. August 1).

In mid-August, Land of Lincoln's Western Regional Office Managing Attorney, Chelsea Hubbard, received a frantic call from a mobile home tenant who, with his family of five, was going to be evicted that afternoon. The Sheriff had stopped by that morning to let the tenant know.

Chelsea called the Sheriff's office and attempted to educate them about the current moratorium that was in place until August 22nd, but the Sheriff's office insisted that it would enforce the eviction of the tenant and other tenants it had slated to evict that day.

Chelsea immediately called the State's Attorney, who intervened with the Sheriff's office and was able to get the evictions stopped. Madison County's Chief Judge issued an order halting further eviction trials and stayed the issuances of summons when evictions were filed. With Chelsea's tremendous advocacy, she was able to stop evictions in this county.

JUSTICE FOR SENIORS

Lauretta, a senior citizen living in an assisted living facility, called Land of Lincoln after she received an eviction notice. She was at risk of being kicked out of the facility because of a \$61,000 Medicaid penalty she incurred when her estranged husband sold property several years back. She filed a hardship waiver with the State, but it was immediately denied.

A Land of Lincoln attorney, Megan Kinney, helped Lauretta appeal the denial, and showed the State that she never received the proceeds from the sale of the property. She was separated from her husband and had no chance of recovering any money she was penalized for.

After negotiating, the State eventually reversed course and approved the hardship waiver for Lauretta. Her Medicaid penalty was waived and she was no longer at risk of being removed from her home at the facility.

Like many of our clients, Lauretta had several other legal issues. In addition to her assisted living facility eviction case, Land of Lincoln attorney, Nathan Elwood, assisted her in divorcing her estranged husband. In the midst of the divorce, we discovered that Lauretta had not received her pandemic economic stimulus payment of \$1,200, which would help her afford incidentals like toothpaste. One of our paralegals, Felicia Voelkel, patiently facilitated calls between the IRS and Lauretta, and within a few days, she received her stimulus payment.



JUSTICE FOR DOMESTIC VIOLENCE VICTIMS

Ruth, a mother of two young children, sought our assistance with an order of protection and a divorce from her abusive husband. Ruth had suffered abuse throughout their marriage. Her husband had beaten and choked her in the past, and he was emotionally abusive. When Ruth told him she wanted a divorce, he obtained an Emergency Order of Protection against her by falsely accusing her of being abusive. She was forced to temporarily leave her home, and he gained temporary custody of their children.


A Land of Lincoln attorney represented Ruth in court and prevented a wrongful plenary order of protection from being entered against her. While our attorney was representing her in the divorce proceeding, our client's husband began harassing her via text messages and told their children that he was going to kill their mother. Our attorney represented Ruth in an order of protection hearing, and the court granted a Plenary Order of Protection.

In the divorce proceeding, the court awarded Ruth with primary custody of the two children, and her ex-husband's visitation was restricted to every other weekend. The court also awarded Ruth possession of the marital home.

Ruth was thrilled with the result, and she and her children are now living their lives free from violence.




CLOSED CASES BY OFFICE




